If you're selling a used car and cannot find the title, apply for a duplicate title with your DMV. Ideally, you should do this before advertising the vehicle.

The Truth in Mileage Act, a federal law, requires the seller of a motor vehicle to provide an odometer disclosure to the buyer at the time of sale or transfer of ownership. This applies to all motor vehicles less than 10 years old up to and including 12,000 lbs.

A bill of sale is a document recording a transaction between two parties. For the seller, a bill of sale shows the date the vehicle was sold and information about the buyer. For the buyer, it gives specific information about the vehicle that can be checked against a Vehicle History Report.

For private sales if you're buying or selling a used car, print two copies out and complete them in front of the other party. Both buyer and seller should sign and keep a copy of this document as proof of sale.

### Car buyer's/seller's contract

Form 130-U In addition to the title, ask the seller to provide you with the signed vehicle title application, Form 130-U, and any other supporting documents, such as a release of lien or power of attorney. Keep a written record that includes the name and address of the seller, date of sale and vehicle information, including the VIN.

If this document is meant to record the sale of a "Boat" then you must mark the second checkbox. As with the previous choice, some facts regarding the boat must be included. Use the spaces in this choice to record the Boat's "Make," "Length," "Title #," "Hull ID#," and "Odometer Hours."

### Notice of Sale and/or Bill of Sale for a Motor Vehicle ...

When you sell your car in Illinois, you are obligated to take the following actions: Remove the vehicle's license plates. Supply the buyer with a valid, signed, and dated title certificate at the time of sale. Both you and the buyer will need to complete the title assignment section.

If you wish to have a record of the sale, you may also complete the Instructions for Selling a Vehicle form MV2928. The Bill of Sale is provided for your convenience, it is not a required form. You may keep a copy with your records, and make a copy for the buyer as documentation of the sale.

Meet all requirements for sale and legal operation at the time of the sale. OR, Have ownership transfer documents that clearly state the car is unsafe to operate.
